2.0 STATEMENT OF THE CHIEF EXECUTIVE

One of the major handicaps, which has been preventing the smooth registration process, particularly in the field of industrial property and specifically Trade and Service Marks, is the erratic and irregular advertisement system for new marks that require registration.

The Trade and Service Marks Act requires such marks to be advertised first before they are registered to give an opportunity to third parties with grounds to oppose the registration of the applied mark.

Registrar has been using the Government Gazette publishing system to carry out that requirement. For a number of reasons, the Government Publishing System could not meet the statutory period required for a mark to be advertised, causing a lot of dissatisfaction and complaints from trade and service marks stakeholders.

BRELA as one of its strategies to improve service delivery to trade and service marks stakeholders, decided to start publishing its own journal which will carry among other intellectual property related publications the trade and service marks advertisement for purposes of registration processes.

We hope our trade and service marks stakeholders and indeed others with interest in intellectual property issues find this monthly publication worthwhile.

The relevant legislation permits BRELA to issue this publication.

3.0 EDITORIAL

This move besides improving our service delivery by reaching our clients and stakeholders in time, the journal shall serve as fora for sensitising the public on issues of Intellectual Property Rights. It is intended that the journal will be in circulation every month.

Due to rapid change in technology and the increase in the workload of the Intellectual Property department, this journal is viewed as one of the means by which information on Intellectual Property shall be disseminated. Any comments, Proposal, advice or question is capable of being dealt with and or availed through this Journal.
